## Prince William County Police Department Live Entertainment Security Plan Checklist

The intent of the following checklist is to assist the applicant in preparing a security plan as part of an application for a Certificate of Live Entertainment (CLE). It is not intended to serve as the security plan for an establishment.

## Security Guards

Certification, number, and positioning within/outside the establishment.

## **General Security**

Maximum occupancy, reporting of threatening, intimidating, or criminal behavior and emergency evacuation.

## **Age Restrictions**

Curfew ordinance and visual age/identification checks.

## Signage

No loitering policy and posting of signs.

The District Commander or his/her designee may modify any security plan submitted if it is determined that the approved live entertainment jeopardizes the health, safety, and general welfare of the public.

Failure to comply with all conditions of any approved security plan could result in a suspension of an establishment's CLE. Subsequent violations could result in a permanent revocation.
