Staff persons David Kroeger, Patti Pakkala and DPR Deputy Director Janet Bartnik were present. Deputy Director David McGettigan, Eugene Loew, Kevin Wyrach and Robert Boyd attended virtually.

**Call to Order**

The meeting was called to order by Amy at 6:30 PM.

**Pledge of Allegiance**

**Administrative:**

- August 27 T&BC minutes were approved through a motion by Neil and seconded by Jason.
- September 16 Powell's Crossing Meeting Notes were approved through a motion by Lynda and seconded by Duane.
- September 18 Gap Study Stakeholder Meeting Notes were approved through a motion by Eileen and seconded by Ken.

**Citizen's Time.**

- Russell Bryan reported on a tour he took and emphasized CIP suggestions.

**County Agency Representatives**

**PWC Department of Parks and Recreation (DPR).** Janet Bartnik, Patti Pakkala, David Kroeger

- Patti reported on the Powell's Creek crossing meeting and stated that the shown design and layouts were available.
- In discussions about Potomac Shores trails, Patti reported that the current PHNST trail will be built to the site plan even though this lower trail is not what is desired for the PHNST. Two sites are still not designed or built, and these will be documented in their site plans when the developer is ready. This is when DPR will work with the developer to get the need upper part of the trail with Potomac views built.
- David provided a summary from Ed DeLeon of Occoquan Greenway updates.
  - Segment 2 Bridge
  - DPR is currently working with the county's procurement office to contract the construction of this bridge crossing.
  - Segment 4 Bridge
  - The Segment 4 bridge crossing work should be completed in the next two months. After the bridge construction is completed, final grading will take place, plantings will be made, and trail paving will be completed on the north side of the crossing.
  - Segment 6 Bridge and Remaining Segment 6 Work
  - DPR is working with Prince William Water to address comments regarding the proximity of an existing sanitary sewer forcemain to the bridge abutment. PWW wants to ensure the protection of the forcemain during excavation for the eastern bridge abutment. This discussion is ongoing. There is no deadline, but Ed feels confident that this project will be completed in 2025.
  - To finalize the Segment 6 trail from the Hooes Run bridge to Captains Court, DPR is negotiating an engineering contract with a consultant to complete the design and permitting for a fair-weather crossing (exact design TBD) at a stormwater outfall stream near LRPR's property at 12416 Colby Drive. Additionally, this contract will include surveying services to finalize the trail easement plats for the remaining portion of the Segment 6 trail (Hooes Run Bridge to Captains Court).
  - Segment 7 Trail
  - The engineering contract for the remaining Segment 6 work will also include surveying services to complete the easement plats for the Segment 7 trail. Only minor site work is needed to make the Segment 7 trail usable. DPR will be hiring a contractor to maneuver existing boulders within the creek beds to create walkable stream crossings at three locations, however this work has not yet been contracted.


- Patti reported on Broad Run Greenway progress for a potential section of the trail from Route 28 to Saybrook Place. She also mentioned a connection to Hornbacker Road where a bench and Kisok will be sited.
- Janet thanked Trails Keepers and others who helped at the Sohlheim Cup. She described experiences from working at the concessions.
- Janet mentioned the KABOOM playground construction in late October at Fairmont Park. Ribbon cutting will take place on October 26. She recommends volunteers sign up for Wednesday, Thursday or Saturday as there may not be anything to do on Friday if they make good progress on prior days. Several organizations have pledged teams to help.
- Janet mentioned the Find-a-Trail link and its status.

**PWC Transportation.** Kevin Wyrauch

- Kevin reported on the Comprehensive Safety Action Plan. It includes safe streets, multi-modal transportation, sidewalk gaps, crash analysis and bike gaps. Final products should be completed by early October. He showed a draft crash analysis including a frequency map. As part of this plan, they are looking at how to mitigate these problems and will create a working group. They are looking for a volunteer from the T&BC to be part of this working group.
- It was reported that a bike and pedestrian counter is being added to the Brentsville Crossing of route 234. They are looking for other locations where such counters would be useful for gauging usage.
- Eileen asked about decision points for choosing types of crosswalks – VDOT guidelines used.
- Joe asked about what guidelines are used for placing stop or yield signs on shared use paths since he has observed various approaches across the county.

**PWC Planning, David McGettigan**

- Yolanda discussed the plan for the Sudley Corridor Study Update which follows Sudley Blvd from the City/County line to the Community College. A ULI panel will be formed and request information from stakeholders including the T&BC. This should result in a planning document that is expected to be completed by March or April of 2025.



- David McGettigan, the Deputy Planning Director, was introduced and took part in the meeting.
- Crossing Catharpin and providing access to a trail was discussed.

**Community Development Applications, Patti Pakkala**

- Maple Valley Grove is near Hoadly Square and contains 224 townhouses. There is no draft proffer statement to review. Multiple people were concerned about the lack of pedestrian crossings on Hoadly Road in that area and adding more living units will only make this worse.

**Presentations/Reports.**

**Various Recent Trail Exploration Presentation, Joe Marshall**

- Joe gave a presentation (see attachments) covering multiple trail and blueway topics from his past two months.
- He summarized the North Country Trail, a larger national trail stretching along the north boundaries of the US from Vermont to North Dakota. He showed pictures and trail signs both along the trail and in Isle Royale National Park.
- He showed pictures from the ribbon cutting for the Featherstone section of the PHNST.
- He described his exploration of the Bull Run Occoquan Trail north of Route 28 in Fairfax to scout out potential put-ins on the Prince William County side. He described bicycle trails in the Virginia Beach area including in two state parks and two National Wildlife Refuges.

**Trail Segment Rankings by District for CIP Development, Janel Bartnik**

- Janet collected prioritized inputs from each district for implementation and funding of future CIP projects.

**Occoquan: (see attached slides)**

- Ellicott Street connection – is it fully funded?
- PHNST connection – Town of Occoquan to Belmont Bay – nearest the water
- OG Trail – segment 8 – build the stormwater pond bypass and loop through the open area.(dotted line on image in slides)
- Trails in powerline corridors in Lake Ridge (between Old Bridge and Minnieville Rd)
- OG – Segment 2 – additional restoration work is needed in sections not renovated in 2016
- Minnieville Road pedestrian improvements – between Fowke Lane and PW Pkwy – better striping for pedestrian safety (crosswalks and paint should be done!)
- Sidewalk on Caton Hill Road for access to the Target store; new townhomes are being built – Lawton at Telegraph

**Woodbridge (sidewalk study list)**

- On Blackburn at Maryland: no sidewalks from Rippon MS to Featherstone Elementary on the school side of the road. A dirt trail is visible.
- ADA parking at the boardwalk is not done yet
- Blackburn/Colchester at Dorothy to Randall has no sidewalks.
- In Old Belmont, area of Belmont Elementary School has no sidewalks on Norwood.
- Dawson Beach Road needs a sidewalk to the Wildlife Refuge
- Sidewalk gap on Belmont Drive at Dawson Beach (one house)
- Community with the streets: Marumsco and Woodbridge streets have no sidewalks
- On Horner Road: only has sidewalk opposite Kirby Elementary School from Occoquan Road area. (development coming – will need more sidewalk)
- York Drive at PW Parkway: no continuous sidewalks to get to Elizabeth Vaughan and Woodbridge MS.

- Powell's Creek Crossing – if additional finding is needed

- FLAP grant design of segments identified
- Feasibility study for RR tracks crossing in Cockpit Point
- Dewey's Creek

### Recreational Trails

1. Broad Run Greenway – from Dove's Landing to Route 28 (some funding in place)
  - i. \* Doves Landing new eastern property trails, especially across from Sinclair Mill
  - ii. \* Trail through Sinclair Mill to Preserve at Long Branch via a crossing (low-water or bridge over Long Branch)
  - iii. Follow Broad Run from Doves Landing to airport, Cannon Branch and connection to other districts
  - iv. Ped Bridge over Occoquan River between Dove's Landing section
2. Flat Branch Greenway (unfunded)
  - i. \* Ben Lomond Park to Godwin Drive along Flat Branch (adjusted for Bypass as needed)
  - ii. \* Connections to Yorkshire area
  - iii. Low water crossing of Bull Run or bridge just north of confluence of Flat Branch and connection to Bull Run Occoquan Trail
3. Powell's Creek Greenway North (unfunded)
  - iv. Landfill Discovery Trail expanded to Minnieville Road
  - v. Minnieville to Spriggs along social connections
  - vi. Connections and trail to Forest Park HS and Lake Montclair (other districts)
4. Cannon Branch Greenway
  - i. Trail from VRE tracks to Broad Run on east Side of Airport
  - ii. Winter's Branch trail from Godwin to Cannon Branch (not in comp plan but a great connection to Manassas)

### Bike / Pedestrian Trails

1. Route 234 Business from Brentsville Interchange to Manassas city limit – a small section still without a bike trail
2. Route 234 Bypass from Brentsville Interchange to Route 28 (and beyond in other districts).
3. Hoadly Road from Route 234 to Spriggs Road (and beyond in other districts)
4. Route 28 from Manassas Park to Bull Run
5. Bristow Road from Route 234 to Brentsville and beyond
6. Brentsville Road from Route 234 to Bristow Road including 90-degree Sharrows to Doves Landing Park
7. Lake Jackson Road from Route 234 to Route 294
8. Davis Ford Road from Yates Ford Road to the Occoquan River and beyond
9. Lucasville Road from Brentsville to Manassas
10. Yates Ford from Route 294 to Bull Run
11. Sudley Road from Godwin north and beyond (very small segment in Coles)

### Blueway Access Points

1. \* Boat Launch and parking at Sinclair Mill along with road improvements from Sinclair Mill Drive – this is currently being planned as part of the Dove's Landing Design.
2. \* Boat Launch and parking at Dove's Landing on north side of Occoquan River - this is currently being planned as part of the Dove's Landing Design.
3. Boat Launch and parking at Route 234 below Dam – today this is a very tough carry with no formal facilities

4. Boat Launch and parking at Route 294
5. Boat Launch and parking along Bull Run near Route 28 bypass route south of Flat Branch

**Brentsville**

1. (2) Broad Run Greenway Trails:
  - i. The east side of Broad Run Greenway leading from Victory Lakes to the Sowder Village shopping center (Target on Rt. 28) comprised of 1.3 miles of natural surface or stone dust trail.
  - ii. The expansion of the trails located off of Hunting Cove Place to create an accessible trail network, coupled with having an accessible parking/picnic area.
2. Trail to connect the Bristow Station Battlefield Historic Park to Valley View Park, either along the railroad track with the future adjacent Thomas Farm and Savage Farm under development or along Rt. 619 through Bristow.
3. Trail along the Dawkins Branch tributary blueway heading towards Broad Run that flows under the brand new University Blvd overpass located between Broad Run and the Virginia Meadow Industrial Park.
4. Extension of Rocky Run Greenway to Glenkirk Rd.
5. For transportation = completion of any pieces of the 234 Bypass trail but especially extensions in both north and south direction of the intersection with Route 28. Broad Run greenway trails segments. ADA accessible trail loops at trailhead in Broad Run trail corridors, Dove's Landing, etc.
6. Innovation Park intersection safety

**Gainesville (See attached slides)**

1. SUP – west side of 15 from Simons Grove to Waverly Farms Road with connector from Catharpin Greenway under Rt. 15, extending to James Long Park
2. SUP – Battlefield HS to Catharpin Greenway to Catharpin Road
3. SUP – Old Carolina Road from Somerset to Haymarket Town Line

**Neabsco**

Urban

1. Hoadly Road from PW Parkway to 234 needs pedestrian accommodation
2. Smoketown between Beaver Ford and Traeger – need connectivity
3. Elm Farm Road has cow paths on side and needs pedestrian accommodation
4. Sound bound exit out of Queensdale to Dale Blvd; bottlenecks; lots of pedestrians; needs safety improvements

Rural

1. Neabsco Greenway – maintenance as discussed with the Supervisor
2. Jenkins Park – needs a nature trail / perimeter trail


**1. Shared Use Path: Western Side of RT15 from Simons Grove to Waverly Farm with connector from Catharpin Greenway under RT 15, extending to James Long Park**

**Impact:**

- Allows safe access to trails and park without having to cross busy RT 15.
- Completes existing Dominion Valley Dr/Waverly Farm loop and serves Dominion Valley, Greenbriar, Westmarket, and Simons Grove communities.
- West and east paths will access the Catharpin Greenway at Catharpin Creek bridge and close an important gap in the existing Greenway trail.
- Provides safe connection to the James S Long Regional Park.

- James Madison Highway: Loudon CL to Lee Highway
- Catharpin Greenway



## 2. Shared Use Path: Battlefield HS to Catharpin Greenway to Catharpin Rd

### **Impact:**

- A shared use path from the authorized Long Park parking lot near Battlefield HS connecting school facilities and the shared use path on Graduation Drive to the Catharpin Greenway
- Extend to completed portions of the Greenway which connect to the shared use path on Catharpin Rd.
- This connected path will serve Bull Run Middle School and the communities of Dominion Valley (east of RT 15), Piedmont and Longlevel.


### 3. Shared Use Path: Old Carolina Rd from Somerset to Haymarket Town Line

- Will allow access from the communities of Kennard Ridge and Somerset to downtown Haymarket and north to Heathcote Blvd.





Existing project, administered by PWC Dept of Transportation. If not fully funded, provide funding to complete the project.




## PHNST connection – Town of Occoquan to Belmont Bay

Route going under I-95 and Rt 1 bridges. May require acquisition, easement, or proffer. Will need VDOT permit.




### Occoquan Greenway Trail – Segment 8

## Occoquan Greenway Segment 2



Particularly through all the intersections - better striping, signaling, and bike/ped islands should be reviewed.




## Sidewalk on Caton Hill Road for Access to Target store

2024 Trails and Blueways Proposed Goals

4. Support and encourage PWC CIP additions for trails outside of bonds and additional trail maintenance funds.
5. Finish arranging plans and approaches for gaps in PHNST. Establish a traceable schedule to track in future years completing in 2031.
6. Encourage and track changes and updates to the Occoquan Greenway culminating in completion of this route from McCoart to Occoquan in 2025.
7. Inventory and identify gaps and approaches toward completion of the Broad Run Greenway.
8. Inventory and identify gaps and approaches toward completion of the Neabsco Creek Greenway.
9. Inventory and identify gaps and approaches toward completion of the Catharpin Creek Greenway.
10. Inventory and identify gaps and approaches toward completion of the Powells Creek Greenway.
11. Inventory and identify gaps and approaches toward completion of a Bull Run Loop trail in concert with Fairfax County.
12. Develop maps, plans, and approaches for one or more blueways in the county.
13. Develop two prioritized lists for each district of recreational trails and bike/pedestrian trails. Get buy-in from each district’s supervisor for the list.
14. Encourage at least one trails or blueways ribbon cutting in each district.
15. Publicity / awareness of the TBC and its work
16. Communication plan to keep Supervisors updated - formalize
17. Get more representation from the Potomac District especially since the potential for a park at cockpit point is coming closer
18. More signage / standardized signage
