Chair Porter called the meeting to order at 7:30 pm.

### Citizens Time

- There were no citizens present.

### Old Business

- The minutes of the February 13, 2025, meeting was approved (Baldwin moved/BruMar – seconded), unanimously.

### New Business

- Resolution to Declare, Affirm, and Recognize April 2025 as Fair Housing Month (Baldwin moved/BruMar second). The resolution passed 6/0.
- Resolution to Declare, Affirm, and Recognize the month of May 2025 as Asian American, Native Hawaiian, and Pacific Islander Month (Baldwin moved/BruMar second). The resolution passed 6/0.
- Resolution to Declare, Affirm, and Recognize the month of April 2025 as Arab American Heritage Month (Baldwin moved/Staubly second). The resolution passed 6/0.

- A discussion was held to change the HRC meeting time. The commissioners present agreed by consensus to a 7 PM start time. The Chair requested that staff contact the commissioners who were not present and query them whether a 7 PM start was good for them.

## **Committee Reports**

### **Unity in the Community**

- Nothing to report.

### **Jail Board**

- The next Jail Board meeting will be held on May 21, 2025.
- The average number of inmates held in the detention center in January was 522, 532 in February, and 548 in March. The center is operating under capacity.
- There were 10 transfers of inmates for January, and 5 transfers in February 2025.
- 522 were committed in January, and 474 were committed in February 2025.
- 540 inmates were released in January, and 484 inmates were released in February 2025.
- The new Superintendent of the Adult Detention Center, Allen West, will present to the Human Rights Commission at its May meeting.

### **Racial Social Justice Committee**

- Nothing to Report.
- The meeting scheduled for March 20<sup>th</sup> was cancelled.

### **Student Leadership Council**

- Cohort 9 has concluded with the graduation, which was held on Thursday, April 3<sup>rd</sup>.
- 52 students graduated from Cohort 9 on April 3<sup>rd</sup>.
- Guests attending the graduation included: Supervisor Victor Angry, Superintendent of PWC Schools, Dr. McDade, CXO of PWC Government Chris Shorter, and Commissioners BruMar, Staubly, and Ginoba.
- A memory book memorializing activities during Cohort 9 will be released next week.
- The office will request that Carolyn Custard be reappointed as the school liaison for Cohort 10.
- Overall, Cohort 9 was deemed a success!

### **Director's Report**

- The Human Rights Office will conduct a "Fair Housing for All" virtual webinar on April 23<sup>rd</sup> at 6:00 PM to commemorate Fair Housing Month. The webinar will feature:
  - Barksdale Haggins from Fairfax County Government, who will provide an overview of the Fair Housing Act.

- Mahalia “Mally” Dryden-Mason from Loudoun County will present case studies and examples of housing discrimination.
- Joan Duckett from Prince William County Housing and Development, who will provide resources for assistance and support.
- Following the webinar, the Office will distribute the quarterly newsletter in May, focusing on Fair Housing.
- The Human Rights Office will be conducting Fair Housing testing on the western end of Prince William County this fiscal year.
- Director Torres will participate in Fairfax County’s Fair Housing Summit, which will be held on May 20, 2025.

### **COMMISSIONER'S TIME**

Kimberly Sparkes—On April 23rd, Commissioner Sparkes will host a Roundtable discussion at the Montclair Library focusing on housing and utility resources for residents of PWC.

Padreus Pratter – Nothing to report.

Benjamin Baldwin – Nothing to report.

Victoria Staubly—The Ordinance training is scheduled for April 30th in the Human Rights Office. As a member of the transgender community, she expressed her hopes of being a resource for the commission.

Evelyn BruMar—The Prince William Chamber of Commerce, Volunteer Prince William, and several other nonprofit organizations hosted a Community Summit to recruit more volunteers.

Curtis Porter – The Chief of Police and PWCPD would like to collaborate with the HRC to address the hate/bias issue in Prince William County.
