Incidents

Felony Hit & Run – On June 23 at 5:58PM, detectives in the 10400 block of Sudley Manor Dr. in Manassas (20109) made contact with the occupants of a vehicle located behind a business. During the encounter, suspected illegal narcotics were observed. As detectives continued their investigation, the driver of the vehicle, later identified as the accused, reversed the vehicle and struck a police vehicle before fleeing the area. Detectives located the vehicle in the area of King George Dr. where it was determined the accused had used the vehicle without the owner’s permission. No injuries or additional property damage were reported. Following the investigation, detectives obtained arrest warrants for the accused, identified as Jessica Siomara **RIVERA-VANEGAS**. Attempts to locate the accused have been unsuccessful.

Attempted Residential Burglary – On June 24 at 1:39PM, officers responded to a residence located in the 15400 block of Silvan Glen Dr. in Dumfries (22025) to investigate an attempted burglary. Video footage revealed an unknown juvenile male approached the house at approximately 3:39AM where he then attempted to push open the front door before leaving the area. No entry was made into the home, and no property was reported missing.

Reckless Handling of a Firearm – On June 18, officers concluded an investigation into a reckless handling involving a firearm that occurred in the 12000 block of Bradley Forest Rd. in Manassas (20112) on March 21. The investigation revealed the accused fired rounds in the direction of the neighbor's property. Officers responded the day of the incident and conducted an initial investigation. No injuries or property damage were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Ronald Wayne **HALL Jr.**, who was arrested on June 18.
