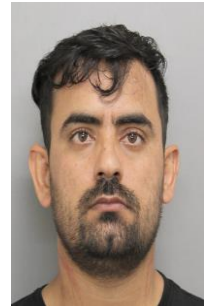

The investigation revealed the victim, a 45-year-old man, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim multiple times and took the victim's property before the parties separated. Officers located the accused at the scene where he was detained without incident. Minor injuries were reported. Following the investigation, the accused, identified as Sajed **STANIKZAI**, was arrested.
