# DAILY INCIDENT REPORT

July 3, 2025

## Incidents

**Carjacking [Domestic]** – On July 2 at 8:17PM, officers responded to the 9400 block of Liberia Ave. in Manassas (20110) to investigate a carjacking. The investigation revealed the victim, a 63-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated inside a vehicle. During the encounter, the accused forcefully grabbed the keys and then pulled the victim out of the vehicle before driving away in the vehicle. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Peshwaz Azad **WAISE.** Attempts to locate the accused have been unsuccessful.

Peshwaz Azad **WAISE,** 37, of the 8500 block of Brickshire Ln. in Manassas Described as a white male, approximately 6'7", 180lbs., with balding hair and brown eyes Wanted for <u>carjacking</u> and <u>domestic assault & battery</u>

**Unlawful Filming –** On July 2 at 12:32PM, officers responded to Miniso inside Potomac Mills located at 2700 Potomac Mills Cl. in Woodbridge (22192) to investigate an unlawful filming. The investigation revealed the victim, a 13-year-old female juvenile, was with her family when an unknown man was observed crouching down and taking inappropriate photos of the victim. Store security had a brief encounter with the suspect before he left the store. No physical interaction occurred between the suspect and the victim. The suspect was described as a Hispanic male with short hair last seen wearing a white polo-style shirt with dark-colored jeans and shoes.

### Arrests

**Felony Child Neglect** – On July 1 at 2:41PM, officers responded to investigate a child neglect that was reported to have occurred at a residence located in the 14600 block of Potomac Branch Dr. in Woodbridge (22191) earlier that day. The investigation revealed the victim, a 2-year-old boy, had ingested illegal drugs while in the care of his father, identified as the accused. The accused eventually brought the victim to an area hospital for treatment before leaving prior to police arriving. The father was not immediately located. The victim is expected to recover. Detectives executed a search warrant at the residence where items of evidence were located. Following the investigation, the accused, identified as Rhamirr Ahmad **BROWN**, was arrested.

**Strangulation [Domestic] –** On July 2 at 12:07PM, officers responded to the Linden Park Apartments located in the 3600 block of Jurgensen Dr. in Triangle (22172) to investigate a domestic dispute. The investigation revealed, the victim, a 22-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated earlier that morning. During the encounter, the accused grabbed the victim's phone and prevented her from leaving before pinning her down and grabbing her neck. Eventually, the parties separated. Non-life threatening injuries were reported. Following the investigation, the accused, identified as Khalil-Anton Donnell **FRAZIER Jr.**, was arrested.
