### Updates

**Strangulation \*ARREST** – On August 7, the suspect, identified as Tyron Reshawn **JOHNSON**, who was sought in connection to a domestic assault that was reported to have occurred at a residence located in the 2500 block of Vantage Dr. in Woodbridge (22191) on July 23, was arrested.

**Strangulation [Domestic] [Previously Released]** – On July 23 at 5:28PM, officers responded to the Ascend Rippon Apartments located in the 2500 block of Vantage Dr. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 44-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused got on top of the victim and pushed her face into the bed before he struck her. The parties eventually separated, and the accused left the apartment. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Tyron Reshawn **JOHNSON**. Attempts to locate the accused have been unsuccessful.

## Arrests

**Brandishing a Firearm [Road Rage]** – On August 7 at 9:55AM, officers responded to the area of Richmond Hwy & River Heritage Blvd in Dumfries (22026) to investigate a road rage incident. The investigation revealed the victim, a 47-year-old man, was driving in the above area when he was involved in a road rage incident with the driver of another vehicle. During the encounter, the other driver, identified as the accused, allegedly brandished a firearm towards the victim. No shots were fired, and no injuries were reported. The parties separated and the victim reported the incident to the police. Following the investigation, the accused, identified as Latrice Latoya **COOKSEY**, was charged and released on a court summons.

**Possession of a Weapon on School Property [Past Occurrence]** – On July 26, 2025, officers concluded an investigation into a weapons offense that reportedly occurred at Rosa Parks Elementary School located at 13446 Princedale Dr in Woodbridge (22193) in September 2024. The investigation in the incident began on June 27, 2025, after a photo was located allegedly depicting a juvenile male, later identified as the accused, holding a firearm at a location determined to be on the school's property. The photo was reportedly taken over a weekend on September 29, 2024, when no students or staff were believed to be present on site. The photo showed the accused near the back portion of the school's property, away from the building. The weapon is not believed to have been fired, and there were no indications of threats of harm to the school, students, or staff. Following the investigation, charges were obtained against the accused, identified as a **16-year-old male juvenile**, on July 26, 2025.

**Assault & Battery on a Law Enforcement Officer [LEO]** – On August 5, officers were on an unrelated call at Sentara Northern Virginia Medical Center located at 2300 Opitz Blvd in Woodbridge (22191) when they encountered the accused who was seeking treatment. While at the facility, the accused began destroying hospital property when officers attempted to speak to him. Due to his behavior, officers attempted to detain the accused who struck one of the officers multiple times to the head. The accused was eventually detained. No injuries were reported. Following the investigation, charges were obtained against the accused, identified as Troy Allen **PHILLIPS**, Jr., who remains hospitalized.
